From the Pastor:

"A Solid Foundation: Part Three, Reliability of the Gospel Authors" 1

Last month we showed how the Gospel documents (and the rest of the New Testament for that matter) stand up under legal scrutiny, showing them to be reliable in the sense of reflecting what was written by the original author. However, the skeptic is not done yet. They say, and this is true, "The fact that the documents are reliable as documents does not, in and of itself, mean that what is written on them is true." In other words, how do we know that What Matthew, Mark, Luke and John wrote is the truth? This is an important question, since these authors record critical things that we base our faith upon, including the teachings and miracles of Jesus, His brutal crucifixion, and His bodily resurrection and ascension. So we have what the Gospel authors wrote, but can we trust what they wrote?

First, it must be remembered that testimony is assumed to be truthful unless it can be impeached or proven false under cross-examination. This is true in law and in everyday life, as those who assume that everyone is always lying are rightly considered to be paranoid! Therefore, when attacking the reliability of the Gospel writers, the burden of proof is rightly *on the skeptic*. So the question is, "Can he/she meet this burden of proof?"

First, let's consider the authors. Do they seem to be the type who would "bend the truth" in order to put themselves or their pet cause in the best possible light? A careful reading of the Gospels quickly dispels this. First, the authors go out of their way to claim that what they are writing is not fable but fact, giving historical referents for dating purposes. Thus if what they wrote was false, it would have been immediately disproved, especially with so many people who were hostile to their message present, including those in power. Second, they are fully honest, showing the faults, failures and misunderstandings of themselves and their associates.² Both of these facts debunk the "clever liar" concept.

In addition, considering the claim that they had *reason* to lie to enhance their own standing in the early church and/or gain economic benefits, again just consider the facts of history. Those who willingly testified of

their faith before earthly authorities consistently lost property, honor and even life. One has only to consider that if earthly benefits were their goal, they were *absolute fools*. (So foolish, that you wonder how they could have come up with such an elaborate concept in the first place!) In addition, the apostles without fail gave up their wealth *for others*, and do not hoard it. And in the end, since all the apostles but one were martyred for their faith,³ how likely is it that they would have willingly died such horrific deaths for a lie they concocted, and one that gave them *little to no earthly benefits* on top of it?⁴ Sometimes *common sense* is all that is needed to see the blindness of skepticism!

But what about defects in their *testimony*? It is often claimed how they don't give identical accounts of all the events they record. Surely this must prove the testimony as defective, right? Actually, it only *strengthens* the case for them.

While it is true that each author highlights certain things, and that they will tell the same event from a different perspective, sometimes giving additional details, they are *not* contradictory. In fact, the presence of four different *but not inconsistent* versions of events is one of the strongest evidentiary factors in favor of the integrity of the Gospel writers. Identical statements by witnesses is one of the surest signs of collusion. In a court of law, the so-called differences in the Gospels are a stronger confirmation to their authenticity than if they matched up perfectly word for word.

Finally, we must examine if outside evidence supports or hurts the Gospel testimony. Parton writes, "In fact, archaeology has been the best friend Christianity could hope to have, and its results repeatedly are found to vindicate New Testament geography, chronology, and history." As an example, it was claimed that since there was no secular evidence that a man name Pontius Pilate ever existed, he obviously didn't (since you *can't* trust the Gospel documents!). But then in 1961, the "Pilate inscription" was found, a pagan reference to Pontius Pilate, and once more the Gospels were shown to be accurate.

In conclusion, speaking solely from what would be accepted as testimony in a court of law, *the Gospels pass the test*. In the words of Parton, "We may confidently conclude that the Gospel writers withstand the most rigorous cross-examination, not only as to their character but also as to the content of their testimony." We recognize that our "blind faith" in the Bible (as we are accused of having) is shown to stand up to solid critical thinking and, therefore, is not be blind at all. In fact, it is those who attack the Bible that are showing themselves to be "blind skeptics."

My hope and prayer is that this small delving over the last three articles into the realm of Christian apologetics (defense of the faith) has strengthened your convictions in the Bible truly being the Word of God as it claims to be and will give you more confidence in your witnessing to those who have not been brought to this conviction yet. If you are interested in studying apologetics deeper, I would strongly encourage you to read Parton's book from which I've been drawing. I also have other recommendations if you're interested.

³ John was not martyred, but his brother James was the first apostle to die (Acts 12:2; consider that Stephen was already martyred for his faith). In addition to losing his brother and friends/fellow apostles, he also saw other faithful believers die and was himself exiled to a penal colony on the island of Patmos for a period of time due to his Christian witness (Rev 1:9).

If this were true, they would have willingly been executed in horrific ways for a known lie, a lie that if given up would have allowed them back into "normal" life and society. APOLOGETICS: Strawman and bandwagon fallacies9

In the beginning was the Word ($Logos \Lambda \acute{o} \gamma o \varsigma$), and the Word was with God, and the Word was God (John 1:1).

Followers of Jesus Christ, called the *Logos* in <u>John 1</u>, should be logical in their arguments. Those who don't follow Him have no such restrictions. This shows in the many logical fallacies used against biblical creation. My previous two editorials have discussed the importance of correct logic and refuting fallacies. ¹⁰ This article begins a new series on logical fallacies: how to spot and refute them.

Straw Man (and Weak Man) Fallacies

Often, evolutionists don't refute the actual creationist position but instead refute a silly position held by virtually no-one. This fallacy is often called 'knocking down a straw man.' A related fallacy, 'weak man', refutes an argument made by *less informed* people but long ago rejected by the leading proponents. For example, the biblical creationist position is that God created different kinds, each with the capacity for lots of variation. Saying that creationists deny that species change, i.e. believe in *fixity of species*, would be a straw man.

Sometimes the straw man is not stated explicitly but implicitly in an argument. E.g. claiming that since breeders have made many varieties of dogs, evolution is true and biblical creation is false. But this is not countering the biblical creationist argument. In fact, creationists both before and after Darwin *rejected* fixity of species. Fixity of species was actually pushed by Darwin's mentor Charles Lyell, the leading promoter of long-age geology.

We have seen 'weak man' fallacies when an evolutionist tries to disprove creation by arguing against a real person who used an unsound argument. For example, 'Women have one more rib than men.' Some people really do believe this. However, CMI long ago pointed out why this is false (see CMI's list in https://creation.com/dontuse). In short: amputees don't have amputee children, and the Bible doesn't imply otherwise.

The straw man argument can work both ways. E.g., there is certainly a place for showing up evolutionary frauds and retractions, especially to undermine their dogmatic certainty. However, CMI articles, books, and talks tend not to major on these. Rather, we want to show that even the evolutionist's *strongest* case fails badly.

Bandwagon Fallacy

In 19th-century USA, a bandwagon was a wagon that carried a circus band, which attracted a crowd. Politicians decided to use bandwagons in their campaigns. The term 'jump on the bandwagon' became commonly used for joining a popular political campaign. Later, the term was extended to mean following the crowd or majority in any opinion. The fallacy is also called *appeal to the majority* or *appeal to the people* (in Latin: *Argumentum ad populum*). However, the majority is not always right.

Probably, the reason most people provide for believing in evolution is 'most scientists are evolutionists'. But if you asked most of these scientists why they believe in evolution, most will also respond, 'because most scientists believe it.' In the vast majority of scientific work, evolution plays no part. Another reason is that many scientists are just unaware of the strong case for creation. Or else, the only arguments they have heard are straw man or weak man fallacies.

However, the minority can be wrong too. We should avoid the reverse fallacy of rejecting something just because a majority believes it. E.g. 'Are you going to be a mindless conformist sheeple following the crowd?' At CMI, we are *pro-Bible*, not anti-establishment for the sake of it.¹¹

And so conspiracy theories thrive where God's gift of reason should not permit them, including such ideas as "flat earth," "we never landed on the moon," and other such provably false claims.

Conclusion

Since Jesus is the *Logos*, as imitators of Christ, we should be logical. It also helps us spot many of the fallacies that evolutionists commit. Knowing that should make us more confident and accurate when we witness about the *Logos*.

A LOOK at the LUTHERAN CONFESSIONS

Last month, we continued our reading of XXVIII, Church Authority, confessing the Scriptural truth that the real authority of pastors is that of the Word of God. This month we continue this reading, declaring that bishops/pastors have no right or authority to decree or introduce any rite or ceremony in the Church that in any way goes against the Gospel (again, their authority is that of the Word, not over the Word).

Augsburg Confession Article XXVIII: Church Authority, 30-38¹²

There is also a dispute about whether or not bishops, or pastors, have the right to introduce ceremonies in the Church, and to make laws about meats, holy days, and grades, that is, orders of ministers, and so on. Those who say that the bishops do have this right refer to this testimony of Christ in John16:12-13, "I still have many things to say to you, but you cannot bear them now. When the Spirit of truth comes, He will guide you into all the truth." They also refer to the examples of the apostles, who commanded that Christians abstain from blood and from things strangled (Acts 15:[20,] 29). They refer to the Sabbath day as having been changed into the Lord's Day, contrary to the Decalog, as they understand it. In fact, they make more of the supposed change of the Sabbath day than any other example they can think of. They say that the Church's authority is so great, it has even done away with one of the Ten Commandments.

But on this question, for our part (as we have shown earlier) we teach that bishops have no authority to decree anything against the Gospel. The Canonical Laws teach the same thing (Dist. IX). It is against Scripture to establish or require the observance of any traditions for the purpose of making satisfaction for sins, or to merit grace and righteousness. When we try to merit justification by observing such things, we cause great harm to the glory of Christ's merit.¹³ It is quite clear that by such beliefs, traditions have almost multiplied to an infinite degree in the Church, while at the same time, the doctrine about faith and the righteousness through faith has been suppressed. Gradually more holy days were made, fasts appointed, new ceremonies and services in honor of saints instituted. Those responsible for such things thought that by these works they were meriting grace. So the Penitential Canons increased. We still see some traces of this in the satisfactions.¹⁴

¹³ While it is true that a pastor should never *force* any new ceremony upon a congregation, that is not the main point of this article. Its thrust deals with those ceremonies that are *against the Gospel* by teaching that through doing such ceremonies a person's sin, or its consequences, is in any way, no matter how small, paid for or removed, or that God's grace is somehow merited (earned) by the performance of the ceremony (i.e. God owes us something due to our doing it).

¹⁴ Satisfactions are the third part of the Roman Sacrament of Penance. First, you confess your sins to the priest. Second, he absolves (forgives) you of the *eternal* consequences of your sins. Third, he commands certain satisfactions to be performed which help to remove at least some of the *temporal* consequences of your sins, with whatever remained to be paid for in Purgatory.

CHRISTIAN LIVING

"The Singing Church"

Lutherans have historically been called "the singing church." There is no doubt that music has been a major component in the theology and practice of the Lutheran church. Luther once remarked about music, "We can mention only one point, namely, that next to the Word of God, music deserves the highest praise." Music has a power and purpose that cannot be understated in our worship and the life of the congregation.

But music does more than touch the emotions. Music is a vehicle that carries both the musician and the hearer deeper into connection with the truth of the Scriptures. This is true of the most complex Bach chorale and even the simplest of songs like "Jesus Loves Me, This I Know." Each musical selection within the church shapes the thoughts, minds and faith of the people who experience them.

This is also true of stewardship hymns. We are currently considering the verses of "Forgive Us, Lord, for Shallow Thankfulness" (*LSB* 788) as it shapes our understanding and practice of stewardship. This month we take a deeper dive into verse two:

Teach us to thank you, Lord, for love and grace For life and vision, for a purpose clear, For Christ Your Son, and for each human face that shows Your message ever new and near.

The stanza begins by touching on the truth of the Law. Thankfulness is not a natural posture for fallen humanity. For sinners curved in upon themselves, thankfulness for love and grace is something that must be taught. We are those who hoard and clutch. Our confession of our shallow thankfulness highlights the need for us to learn thankfulness to God.

Thankfulness also points to what we are stewards of: love and grace! All the things we have traditionally called stewardship aren't actual stewardship. Rather, what matters is how we steward the one, true and only treasure: the love and grace of God revealed to us in the Gospel of Jesus Christ. So, all stewardship is stewardship of the Gospel! How can we gaze at the cross and empty tomb and not be thankful?

The LCMS defines stewardship as "the free and joyous activity of God's family — the church — in managing life's resources for His purposes." God's love and mercy give us a clear purpose as we live out our Baptism and practice this joyous stewardship. All we are, all we have entrusted to us, and all we are called to do is to connect others with the love and mercy of God revealed in Jesus!

The faithful steward sings with lips and life of this love and mercy that is ever new and near. In the Scriptures. In the Lord's House. At the Lord's Table. This is where our stewardship song starts and ends. Our family, our co-workers and classmates, and our world need to hear this song!

this year, but we've always been able to make it work! Some of our favorite things to do as a family are read books together, go for walks, play board games, and watch the very popular tv show "Bluey."


God has blessed us with a loving family, and beautiful place to call home in Fort Wayne, and Confessional Seminary to learn from, and now also your congregation and generous support!
